Monitoring Population Health and Spatial Ecology of the Texas Horned Lizard on Tinker Air Force Base, Oklahoma.

- 1. <u>INTRODUCTION</u>: This cooperative agreement is the result of a successful proposal submitted by University of Oklahoma, Department of Natural Resources and Environmental Sciences, entitled "Monitoring Population Health and Spatial Ecology of the Texas Horned Lizard on Tinker Air Force Base, Oklahoma" in response to RSOI: W9132T-21-SOI-0026.
- 2. <u>OBJECTIVES:</u> The primary objectives of this project are:
 - a. Continue long-term monitoring of the Tinker Air Force Base (TAFB) Texas horned lizard population size and density on Wildlife Reserve 3 (WR3) and satellite areas.
 - b. Implement cellular tracking technology (CTT) LifeTags for increased data collection across WR3, including tracking headstarted individuals after their release onto WR3 to compare survival rates of headstarted versus wild Texas horned lizards across major life stages (hatchling, juvenile, adult).
 - c. Develop a baseline understanding of host gut microbiome diversity and structure in wild and headstarted Texas horned lizards.
 - d. Initiate a reptile immunology and pathogen surveillance program to further monitor the health of wild and head started Texas horned lizards on WR3.
 - e. Make informed recommendations for management of the Texas horned lizard population on TAFB and communicate results of this study through publications and presentations at meetings.
- 3. <u>RECIPIENT'S TECHNICAL PROPOSAL:</u> In order to accomplish the work under this cooperative agreement, it shall be necessary for the Recipient to complete the tasks as specified in their technical proposal entitled "Monitoring Population Health and Spatial Ecology of the Texas Horned Lizard on Tinker Air Force Base, Oklahoma", received August 17, 2021. However, in the event of any discrepancy between the Recipient's proposal, amendment, and this Exhibit 1, this Exhibit 1 shall govern.
- 4. <u>PROPOSAL REVISIONS</u>: Proposal revisions are identified herein. This project will be reviewed on a regular basis and revisions may be requested based on the results of the review. In the event it is determined that additional studies will be required beyond the time frame of this agreement, the Recipient may be requested to provide a proposal for continuation of the project and any subsequent work will be funded by modification to this agreement.
- a. MEETINGS/REVIEWS: In addition to the meetings identified on page 16 of the Recipient's proposal, the Recipient shall participate in the following:
 - i. Project Kick-off Meeting: A project initiation meeting will be held via Webex or other virtual venue within two (2) weeks after the date of agreement award. Date and time will be scheduled as mutually agreeable between the GOTR and the Recipient.
- b. REPORTS/DELIVERABLES: In clarification of the reports and deliverables identified on pages 16 & 17 of the Recipient's proposal, the Recipient shall submit separate draft and final reports for the base period and each continuation phase that is funded.
- c. Project Schedule: The Project Schedule provided in the Recipients proposal (pages 17-18) shall be adjusted to correspond to twelve (12) month Phases based on date of award.
- 4. <u>ATOPSEC:</u> All contractor and all associated sub-contractors employees shall comply with applicable installation, facility and area commander installation/facility access and local security policies and procedures (provided by

government representative). The contractor shall also provide all information required for background checks to meet installation/facility access requirements to be accomplished by installation Provost Marshal Office, Director of Emergency Services or Security Office. Contractor workforce must comply with all personal identity verification requirements (FAR clause 52.204-9, Personal Identity Verification of Contractor Personnel) as directed by DOD, HQDA and/or local policy. In addition to the changes otherwise authorized by the changes clause of this contract, should the Force Protection Condition (FPCON) at any installation or facility change, the Government may require changes in contractor security matters or processes.

For contractor's who do not require a CAC but require access to DOB facility or installation.
