Pursuant to Interagency Agreement No: 24-7340-5525-IA between the United States Department of Agriculture, Animal and Plant Health Inspection Service, Wildlife Services (APHIS-WS) and Tinker Air Force Base in Oklahoma, this Work/Financial Plan defines the objectives, plan of action, and budget for the Wildlife Services program to be conducted from 10/01/2023 through 9/30/2024.

I. PROGRAM OBJECTIVE/GOALS

The APHIS WS program is a non-regulatory, federal, cooperative wildlife damage management program whose mission is to provide leadership in reducing conflicts between people and wildlife and has the primary responsibility for responding to threats caused by wildlife. A growing focus of APHIS WS is to help promote the safe operation of aircraft by working with airport managers and operators to document, assess, and manage wildlife hazards at airports throughout the United States. APHIS-WS has the expertise in Integrated Wildlife Damage Management (IWDM) to provide these services. APHIS-WS will mitigate potential and realized wildlife hazards to aviation at the Tinker AFB and surrounding areas. Wildlife Services personnel will continue to assess, monitor wildlife hazards and conduct operational wildlife hazard mitigation to affect a safe aviation environment for DoD flying assets at Tinker AFB, and surrounding areas.

APHIS-WS will establish and continue an IWDM program incorporating direct assistance and technical recommendations at Tinker AFB and associated outlying fields, up to 5 NM radius, deemed necessary to alleviate wildlife hazards to aircraft as well as for the protection of human health and safety. The IDWM program also extends to private property, up to 5 NM radius, near Tinker AFB, after the appropriate access agreements have been negotiated with the property owner(s) (see Section III, para. c. below). The secondary objective will be to reduce damage to property and natural resources caused by wildlife near Tinker AFB.

RESULTS AND BENEFITS EXPECTED

Expected benefits from the presence of APHIS-WS Wildlife Damage Management Biologists and Wildlife Specialists include:

- a. Serve as a member of the Bird Hazard Working Group (BHWG).
- b. Active attendance and technical support within the Bird/Wildlife Aircraft Strike Hazard (BASH) safety team briefings and inspections
- c. Supplement and enhance the overall Natural Resource Program (NRP) for Tinker AFB.
- d. Maintain wildlife management data.
- e. Monitor wildlife activity while evaluating the effectiveness of IWDM program efforts.
- f. Reports preparation on wildlife species presence and seasonal and behavioral activity of wildlife (using qualitative data).
- g. Assistance in bird/wildlife-strike reporting and monthly briefings on the status of the BASH program.
- h. Assistance with the review and revision of the BASH Plan to ensure updated and that effective techniques are in place to reduce the threat of wildlife strikes to aircraft.
- i. Provide data reports for the renewal of an annual migratory bird depredation/salvage permit and state depredation permits, as needed.
- j. Assistance in the collection, preparation and shipment of bird/wildlife strike remains to the Smithsonian Institution for positive identification.
- k. Evaluation off-station airfields, low level routes and military operating areas (MOA) frequented by military aircraft and advise on potential hazardous migration movement.
- Provide training for appropriate base personnel on use of active scare/harassment techniques, as well as placement of static wildlife deterrent devices.
- m. Monitoring and providing guidance on potential migration hazards for low altitude flight operations.

II. PLAN OF ACTION

APHIS-WS personnel will continue to assess, monitor wildlife hazards and conduct operational wildlife hazard mitigation to affect a safe aviation environment for the Department of Defense flying assets at Tinker AFB and associated locations.

APHIS-WS will assign one full-time Wildlife Biologist and one full-time Specialist at Tinker AFB. The Wildlife Biologist will conduct a year-long Wildlife Hazard Assessment (WHA) to identify current or potential wildlife hazards to aviation. The WHA would follow criteria set forth in Federal Aviation Administration (FAA) Advisory Circular 150/5200-38 and include information gathered from:

- monthly wildlife surveys of the base and surrounding areas
- monthly nocturnal surveys approximately 1-2 hours in length to determine wildlife presence
- monthly inspections of base lands and structures to identify wildlife attractants
- development of a database to track trends in wildlife activity and use patterns
- analysis of strike data

At the conclusion of the WHA, a Wildlife Hazard Management Plan (WHMP) would be developed. The WHMP will supplement and strengthen the BASH plan. The WHMP will contain:

- · descriptions of wildlife hazards to aircraft operations
- wildlife species found within the base environment
- seasonal wildlife population and activity trends
- peak wildlife activity periods by day, month, and seasons
- special hazard zones
- environmental factors and human actions which encourage problem species
- legal status of problem species
- develop and implement Integrated Wildlife Damage Management (IWDM) programs to reduce specific bird and mammal threats to aviation

At the conclusion of the WHA and WHMP, APHIS-WS will continue to collect data for annual monitoring reports. Reports will include wildlife population trends, wildlife management efforts including take records, strike analysis, recommendations, etc. WS-OK will submit the annual monitoring report to the BASH committee after the WHA surveys are completed.

IWDM techniques for managing damage caused by birds include all appropriate methods such as, but not limited to, cage traps, decoy traps, pole traps, capture nets, pyrotechnics, pellet guns, firearms, hand capture and various exclusion and harassment techniques. If required, APHIS-WS will be responsible for application of bird toxicants and will adhere to all chemical label restrictions. All pesticides will be stored onsite as designated by the installation commanding officer and approved by TAFB HazMat or at offsite APHIS-WS facilities.

IWDM techniques for managing damage caused by mammals will include all appropriate methods such as, but not limited to, foothold traps, cable devices, firearms, cage traps and hand capture techniques. Only APHIS-WS or designated installation personnel will remove captured animals. APHIS-WS will make all attempts to donate meat from any depredation and dispose of carcasses per state and federal regulations. APHIS-WS will be responsible for the application and maintenance of wildlife damage management devices. All capture devices will be set to reduce the likelihood of non-target catches.

IWDM activities will be performed on or near airfield and primarily confined to the airfield, adjacent and facility boundaries with periodic activities conducted offsite where mammals and birds pose a hazard to aircraft operations. IWDM will compliment NRP activities and coordinate activities with the Natural Resource Program Biologist and Airfield Operations Officer, as well as with local, state and federal officials.

Base personnel will provide the APHIS-WS employee with an area to dispose of carcasses, eggs and nesting material removed from the facilities outlined in this work.

The APHIS-WS employee will submit bird strike components to the Smithsonian Institution when not easily identifiable to enhance bird strike identification and education. Bird strikes will be recorded on official AF webpage (Form AFI 853).

The National Wildlife Research Center, the research branch of the WS program, will be available to offer recommendations on new lethal and non-lethal techniques in wildlife damage management. The National Wildlife Research Center is the world's leading authority on wildlife damage management research. They have assisted the operational WS program on numerous projects across the United States including Department of Defense air bases and commercial airports. Research that

is implemented by APHIS-WS at Tinker AFB will be directed by the National Wildlife Research Center (NWRC). NWRC oversees research only. All research will be coordinated with NRP Biologist and Airfield Operations Officer. All scientific results and publications will be reviewed and approved by Tinker AFB before reports or publications are submitted.

APHIS-WS will continue to participate in natural resources education and awareness activities related to wildlife damage management. APHIS-WS will provide outreach and education materials at those events.

APHIS-WS will, where practicable, provide Media Relations support for Tinker AFB with scientifically based information regarding wildlife and wildlife hazard management at airports.

To the extent feasible and in accordance with applicable laws, APHIS-WS and Tinker AFB agree to coordinate prior to responding to any requests regarding wildlife issues involving APHIS-WS activities at Tinker AFB. APHIS-WS recognizes that the data collected under this Agreement belongs to Tinker AFB and may not be willingly distributed without the consent of Tinker AFB.

Long-term trends related to wildlife hazards at Tinker AFB will serve as measures of accomplishment (e.g., wildlife presence, damaging strikes, etc.). Other measures may include the number of staff trained, number of presentations given, or training received and implemented.

III. STIPULATIONS AND RESTRICTIONS

- a. All operations shall have the joint concurrence of APHIS-WS and the TAFB Installation Commander. APHIS-WS personnel assigned to this project will remain under the direct supervision of APHIS-WS.
- b. Control on Private Lands: An agreement will be executed between APHIS-WS and the landowner, lessee, or administrator before any APHIS-WS work is conducted on nearby private lands.
- c. Control on Public Lands: An agreement or an appropriate NEPA document will be executed between APHIS-WS and the public land administrator(s)/manager(s) before any APHIS WS work is conducted.
- d. The APHIS-WS employee will adhere to TAFB installation and APHIS-WS guidelines/policies while conducting IWDM activities and will have successfully met APHIS firearm safety and other training standards as necessary.
- e. The 72nd Security Forces will provide APHIS-WS employee with the appropriate security identification badges/passes and safety training to allow free movement within the facility. Base personnel will provide escort in restricted areas when needed. Vehicles operated by APHIS-WS within the project area will be equipped with an amber strobe light or other required markings.
- f. TAFB will provide APHIS-WS furnished office space, office/communications equipment and secure storage. Office/communications equipment shall include computers, printers, telephone equipment, associated data lines and two-way radios to facilitate communications between APHIS-WS and installation personnel. Office will be located within the Natural Resources area and/or near flight safety office members. Local oversight for this program will be the responsibility of the Natural Resource Biologist. Ordinance/firearms will be approved by the base Munitions Safety Office, coordinated with Airfield Management, and registered with base security. Point of contact is 72nd Air Wing, Weapons Safety Manager.
- g. Any equipment and supplies purchased under the terms of an Interagency Agreement

- between TINKER AFB and APHIS-WS will remain the property of USDA APHIS WS.
- h. IWDM activities performed on or near runways or sensitive/controlled areas shall be prior coordinated with Security Forces, Airfield Management and Air Traffic Control.
- The APHIS-WS employee shall complete local airfield driving training prior to operating a vehicle on the airfield.

IV. COST ESTIMATE FOR SERVICES

The cooperator will reimburse APHIS-WS for expenses incurred from Tinker AFB tenants receiving services at the following rates; CSAG (56%), Navy (17%) and 72 ABW (27%). Rates are based upon numbers of serviced hangars/buildings. Such costs include, but are not limited to, salary/benefits, supplies/equipment and administrative costs. Total reimbursement to APHIS-WS is not to exceed the annual limit allocated for the project. An estimated itemization of expenses is listed below; however funds may be distributed between itemized categories at the discretion of APHIS-WS if required. Any equipment and supplies purchased under the terms of this agreement will remain the property of APHIS-WS. APHIS-WS staff may be compensated at regular time, night-time-differential, and/or overtime pay rates in accordance with programmatic Directives to accomplish the purpose of this agreement.
